TRAVEL & IMMIGRATION

Have you obtained your F-1 or J-1 US Entry Visa?

Do you have a **physical copy of your I-20 or DS-2019** to carry with you? (*If you received an electronic I-20, please print it out prior to traveling and make sure page 1 is signed.)*

Do your travel plans allow enough time for you to get settled and attend <u>orientation</u> before classes begin?

Do you have all of the documents listed under your category on the ISSS travel page?

Have you ensured that you are exempt from any possible COVID-19 related <u>travel restrictions</u>, whether in the U.S. *or* in countries through which you will be traveling?



IMPORTANT: As soon as possible after arrival, complete the mandatory new student immigration check-in requirements, including the **tutorial** and **arrival form** in iPenn. Failure to check in with ISSS virtually can jeopardize your immigration status.

FINANCES, HOUSING & ESSENTIALS

Do you have a **small amount of U.S. currency** to cover the initial expenses of your arrival (transportation from the airport, meals, etc.)?

If you are bringing a large sum of cash (10,000 USD or more) into the U.S., make sure you declare it on your U.S. Customs Declaration.

Have you made arrangements for **paying Penn tuition** from overseas? See the SRFS website for <u>instructions on making wire payments</u> to Penn.

SISSS

Have you made arrangements for **housing** at Penn/in Philadelphia? Do you need to arrange for temporary housing prior to move-in?

Have you submitted proof of all **required immunizations**, including the COVID-19 vaccine? See the SHS website for <u>instructions on submitting proof of immunizations</u>.

Are you planning to drive in the United States? If so, consider obtaining an International Driver's License from your home country. (You can apply for a Pennsylvania Driver's License 10-15 days after arrival in the U.S. as long as your immigration documents will be valid for at least one year.)

Have you budgeted for the expense of **health insurance**, including coverage for your family if they are accompanying you? See the SHS website for <u>information about insurance compliance</u>.

PACKING REMINDERS

Have you packed all **sharp objects** (pocket knives, scissors, etc.) in your luggage and not in your carry-on bag? If not, they will be confiscated at the airport.

Have you packed a **variety of clothes** to keep you warm and cool during <u>Philadelphia's changing seasons?</u>

Have you packed any **keepsakes or non-perishable food items** from your home country that might be hard to find in the U.S.?

Have you packed an adapter or a converter for your electronic devices?
